STATEMENT OF EGELSTON TOWNSHIP REGARDING EGLE'S PFAS INVESTIGATION

Egelston Township confirms that the Michigan Department of Environment, Great Lakes, and Energy ("EGLE") is claiming that the Township's fire department once used per – and polyfluoroalkyl substances ("PFAS"), and that releases of such substances resulted from past fire department activities, which has migrated to contaminate other properties. The Township respectfully denies that it has any liability based on the limited information now available. The Township submits that its fire department has always attempted to comply with applicable laws and to use safe and effective products. The fire department discontinued using possible PFAS firefighting foam several years ago.

Nevertheless, without waiver of its right and defenses, the Township commits to the following:

- 1. It is retaining an environmental consulting firm to evaluate available data and to advise the Township.
- 2. It intends to cooperate with EGLE in transmitting available information on PFAS testing results, planned actions, and other public steps.


Description:
